Name of the data controller responsible for any data you provide

The data controller responsible for your personal data is Redexis Gas, S.A. ("Redexis"), with registered office at Calle Mahonia 2, 28043 Madrid.

Redexis is a gas distribution company whose operations are governed, *inter alia*, by the contents of Spanish Hydrocarbons Sector Act 34 of 7 October 1998 and the regulations by which it is implemented.

The distribution companies are the owners of the facilities and pipelines that are used to bring natural gas to your home. They are responsible, among other duties, for distributing natural gas through pipelines and constructing, maintaining and operating the distribution facilities designed to bring gas to the points at which it is consumed. In particular, Redexis engages in the following activities, *inter alia*:

- Construction and maintenance of infrastructure.
- Meter reading.
- Attending to emergencies and call-outs.
- Regular inspections of facilities.

The foregoing duties involve the processing of data of a personal nature.

Please bear in mind that Redexis does not supply the gas that you use in your home. This is the responsibility of the companies that sell gas (these being the corporate organisations from which you may engage the supply of gas and which bill you for the amount that you consume).

Gas distributors and sellers operate in a regulated marketplace, pursuant to specific rules under which they are assigned specific tasks. Both types of company exchange personal data in order to assist the duties allocated to them.

The following section explains types of personal data that are collected by Redexis and the uses to which they are put.

What types of data does Redexis collect?

Redexis collects the following personal data:

- Identifying details and contact information (name, ID card, telephone number, etc.), and information on the home in which you live (address, flat, etc.). We collect these data when you sign an order for the installation or start-up of a service, either through the website or the App, or at events organised for the purposes of promoting the use of gas or encouraging the construction of facilities
- <u>Information on consumption and technical data relating to gas equipment.</u> We collect this information when we take readings and when we make compulsory inspections of equipment.



Miscellaneous data offered voluntarily by you when you contact us. If you contact us for any reason (because you wish to make a claim, to give notice of an emergency, to make an enquiry or to make any other kind of request) we collect information of very different kinds that you make known to us, in order to be able to attend to the enquiry or request you are making.

What do we use your personal data for?

We use your data for the following purposes:

- Processing orders received from users for the registration and start-up of the service.
- Attending to emergency call-outs and incidents.
- Resolving claims.
- Making compulsory inspections and performing other duties for which we are responsible under the regulations in force.
- Replying to any enquiries and requests you may make.
- Provided that you have authorised us to do so, we may send you information relating to products and services in the energy sector or information designed to promote the construction of infrastructure for the transportation and distribution of gas, along with the use of gas and other supplementary or ancillary services.

With whom do we share your data?

The different departments at Redexis can access your personal data in order to perform the duties listed in this privacy policy. Redexis also uses various service providers to perform some of its duties (e.g. meter reading, compulsory servicing, etc.). These service providers may change over time. You can find the names our main suppliers at www.redexisgas.es/protecciondedatos

As a gas distribution company, Redexis forwards and receives personal data to and from the organisations that sell gas, and it sends various communications to the bodies and authorities that regulate the gas sector. This exchange of information is made in compliance with the regulations in force, as the company operates in a regulated marketplace, and it is furthermore made for the sole purpose of complying with the obligations by which each company is bound.

Finally, the companies in the Redexis Group may also access your data, with your consent, in order to send you commercial communications.

How long do we keep your data for?

Your data will be kept while we continue to maintain a contractual relationship with you, to ensure that the relationship is properly managed. Once this relationship comes to an end, we will keep your data for the amount of time necessary in order to attend to our legal obligations, particularly those that result from regulatory issues relating to the sector in which Redexis operates. The additional period for which data are kept will not exceed 20 years. Please bear in mind, moreover, that some information may be kept for historical and statistical reasons.

In the event that you have authorised the sending of commercial communications, we shall keep your data until you withdraw your authorisation or we confirm that your data is out of date. In this regard, we may contact you in order to confirm that you still wish to receive our offers and to confirm that your contact details are correct.

Your rights

Pursuant to the data protection regulations currently in force, you may exercise a number of rights:

- You may request access to your data and obtain a copy thereof.
- You may ask that you data be corrected or deleted in some cases.

- You may object to the creation of personalised profiles.
- You may request the restriction of the processing of your data.
- You may request the portability of any data you have provided.

If you have consented to the sending of commercial communications, you have the right at any time to withdraw your consent and we will no longer send you any offers.

Redexis furthermore recognises your right to submit a claim to the DPO in the event that you believe that your personal data have been the subject of improper processing. Your claim will be confidentially investigated and you will receive a response from our DPO. You also have the right to submit a claim to the Spanish Data Protection Agency, especially if you have not received satisfaction following the exercise of your rights.
