## PRIVACY POLICY OF REDEXIS INFRAESTRUCTURAS, S.L.U. EXPROPRIATION PROCEDURES

Redexis Infraestructuras, S.L.U., ("**Redexis Infraestructuras**") has prepared the following Privacy Policy in order to inform you of the ways in which your personal data will be processed. ### **Name of the data controller responsible for any data you provide**

The data controller responsible for your personal data is Redexis Infraestructuras, S.L.U., with address at Calle Mahonia n.º 2, 28043 Madrid.

Redexis Infraestructuras is a company whose main objective is the transmission of gas, building, operating and maintaining a transmission network that facilitates the transmission of natural gas from the main network to urban or industrial centres, whose operations are governed, *inter alia*, by the contents of Spanish Hydrocarbons Sector Act 34 of 7 October 1998 and the regulations by which it is implemented.

The following section explains the types of personal data that are collected by Redexis Infraestructuras as a company engaged in gas transmission and the uses to which they are put.

### **What types of data does Redexis Infraestructuras collect?**

Redexis Infraestructuras collects the following personal data:

- **Identifying details and contact information (name, ID, telephone number, etc.), and information about the property or estate owned (title, registration data, etc.).** This information appears in the expropriation procedure files, and is obtained both from the competent Public Authorities and from the affected parties themselves. You can update this information at any time.
- **Financial information.** For the purpose of the payment of the potential Valuation price for the assets and rights to which the affected parties may be entitled in the processing of the expropriation procedure or within the framework of a potential amicable agreement, they may be asked for banking information (account numbers, ownership, banking institution, etc.).

- **Miscellaneous data offered voluntarily by you contact us.** If the person affected by a forced expropriation contacts us for any reason (because you wish to make a claim, make an enquiry, etc.), we collect information of very different kinds that the affected person makes known to us, in order to be able to attend to the request made, for the purpose of handling the expropriation file.

### **What do we use your personal data for?**

We use the data primarily for the purpose of managing the expropriation file. That includes:

- Managing the expropriation procedure files with the competent Public Authorities.
- Contacting those affected by an expropriation procedure.
- Managing all aspects related to the procedures resulting from the creation, via expropriation, of a pipeline easement.
- Answering queries and requests made by those affected.
- Resolving claims.

### **Authority to process your data**

We process your data on the basis of the regulations governing forced expropriations in the gas sector, to the extent that they require us to collect and process the data of the affected parties in order to manage those files, as well as in the public interest, given that gas transmission is considered an activity of general economic interest. The following are some of the main rules:

- Royal Decree 1434/2002 of 27 December 2002, regulating the transmission, distribution, sale, supply and authorisation procedures for natural gas facilities.
- Spanish Hydrocarbons Sector Act 34/1998 of 7 October 1998.
- Spanish Compulsory Expropriation Act of 16 December 1954.
- Decree of 26 April 1957, approving the Regulations on Forced Expropriation.

### **With whom do we share your personal data?**

Redexis Infraestructuras sends various communications to authorities and regulatory bodies for the correct management of expropriation procedures, in compliance with applicable regulations.

Likewise, the companies that work with Redexis Infraestructuras, S.L. U. and companies belonging to the Redexis Group may access the same in order to attend to the requests of those affected by the expropriation procedure, and to comply with the legal obligations arising from the same.

### **How long do we keep your data for?**

Your data will be kept while you continue to be affected by an expropriation procedure or by the creation, via expropriation, of a pipeline easement.

Once this relationship come to an end, we must keep your data throughout the life of the pipeline in order to meet our legal obligations.

## Your rights

Pursuant to the data protection regulations currently in force, you may exercise a number of rights:

- You may request access to your data and obtain a copy thereof.
- You may ask that your data be corrected or deleted in some cases.
- You may object to the creation of personalised profiles.
- You may request the restriction of the processing of your data.
- You may request the portability of any data you have provided.

Redexis Infraestructuras furthermore recognises your right to submit a claim to the DPO in the event that you believe that your personal data have been the subject of improper processing. Your claim will be confidentially investigated and you will receive a response from our DPO. You also have the right to submit a claim to the Spanish Data Protection Agency, especially if you have not received satisfaction following the exercise of your rights
